**REQUEST TO APPROVE TAX RATE RESOLUTION
(ALL DISTRICTS - 3 VOTES)**

SUBJECT

Approval of the recommended action will enable various entities to levy taxes to finance Fiscal Year (FY) 2026-27 operations and debt service requirements.

IT IS RECOMMENDED THAT THE BOARD:

Adopt the attached resolution fixing the FY 2026-27 tax rates for County, Special District, and School District Debt Service Funds.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The approval of this resolution will enable the Auditor-Controller and Treasurer and Tax Collector to levy and collect the FY 2026-27 basic 1% property tax, taxes that have been approved by voters to pay for debt service on School District bonds, and taxes on countywide general tax and debt service applied to the unitary assessed values established by the State Board of Equalization.

The collection of taxes is necessary to enable the various entities to finance FY 2026-27 operations and debt service requirements.

Implementation of Strategic Plan Goals

Approval of this action is consistent with the Strategic Plan North Star III.G – Realize Tomorrow's Government Today, Internal Controls and Processes. The tax rate resolution will facilitate the collection of taxes that are required to finance expenditures and pay debt service obligations.

FISCAL IMPACT/FINANCING

These revenues have already been included in the various entities' budgets.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Various legal codes, such as Government Code Sections 29100 to 29109, 23027, 50075, Revenue and Taxation Code (RTC) Sections 93, 100, and 135, and Health and Safety Code Section 13911, require that the Board of Supervisors approve the resolution in conjunction with the levying of taxes.

RTC Section 100 requires a countywide rate for general tax and debt service be applied to the unitary assessed values established by the State Board of Equalization. The revenue received from this levy will be apportioned in accordance with this section of the Code. The rate for BNSF Railway Company and Union Pacific will utilize the annual average tax rate reported for Los Angeles County by the California State Board of Equalization under RTC Section 11403 pursuant to the court's decision in *BNSF Railway Co. v. County of Alameda, et al.*, 7 F.4th 874 (9th Cir. 2021). Unitary properties (e.g., Pipeline, Railroad, and Electric) are a group of properties that operate as a unit under the assessee's primary business function. Revenue and Taxation Code Section 100 requires a calculated tax rate comprised of general levy and debt service.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Collection of the taxes will provide necessary funds to finance operations and debt service requirements.
